Liability and Indemnity Clause:

By enrolling your child in our classes, you acknowledge and agree to the following liability and indemnity terms:

The undersigned, parent or legal guardian of the enrolled child, hereby releases, indemnifies, and holds harmless Drez Chinese Academy, its owners, instructors, staff, and affiliates from any and all liability, claims, damages, injuries, or expenses arising from or related to the child's participation in classes at the academy.

The Client, Parents, and Student shall be responsible for the security, safety, and use of their own personal property on Drez Chinese Academy's premises or while otherwise availing of the Services, and Drez Chinese Academy and/or its Staff shall not be held liable for hurt, injury, loss, or damage to the Client, Parents, and Student and any of their personal property arising therefrom.

The Client, Parents, and Student shall be solely responsible for the medical, allergies, dietary, or any other special conditions or needs (whether physical, mental, or emotional) of the Student. While Drez Chinese Academy will endeavor to accommodate, as far as possible, any special requests relating to the Student in respect of the same, Drez Chinese Academy and/or its Staff accept no responsibility for ensuring that the Student complies with or obeys any restriction in respect of and/or is provided with any item or accommodation or does or is prevented from doing anything in respect of the same nor does Drez Chinese Academy and/or its Staff accept any responsibility in respect of any hurt, injuries, or illness to the Student arising therefrom.

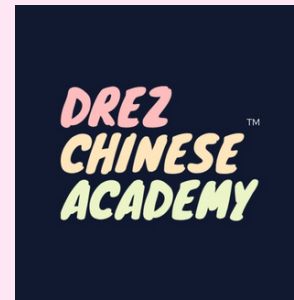

It is the responsibility of the Client and/or Parents to ensure that the Student is sent to, attends at, and leaves Drez Chinese Academy's premises in a timely, safe, and orderly fashion.
